Description of Coverage

The photographer will operate a photo-journalistic approach in accordance with his promotional material. Specific request for portraits will also be accommodated.

Description of Services

The photographer will provide the clients with services from package “ ” as outlined in the attached Services Guide. This package will include the presence of the photographer at the agreed locations for the agreed periods of time as stated in the Services Guide.

Description of Products

The photographer will provide the clients with products from package “ ” as outlined in the Product Guide. The photographer cannot guarantee the prices of albums, prints or digital media long in advance because suppliers’ prices may vary. The photographer will make design decisions about the photographs and will edit the images to create the best possible visual story of the day. The clients will not receive the ‘raw’ images.

Exclusivity

The photographer retains the right to keep copies of all the images. The photographer will be hired to provide sole paid photographic coverage of the wedding. Friends and family are of course permitted to take pictures but they should not interfere with the photographer’s duties. Video coverage of any description does not affect this contract.

Prices and Payment

The price for the chosen package including any written amendments is quoted on the attached product and services guide. A deposit of 20% is required to guarantee the photographers services. This is to be paid on the date of signing the contract. On receiving the deposit and issuing a receipt the photographer will reserve the date(s) specified and not make any other arrangements. The remaining balance will be due not less than 30 days before the event.

Limitation of Liability

Every reasonable effort will be made to provide a professional service and outstanding products. The photographer’s entire liability to the clients for any claim arising from the Photographer’s performance is limited to a refund of the amount the clients paid for the services. The photographer

cannot guarantee to take a certain number of images and cannot promise to make specific portraits. In the event of personal illness or injury the photographer will arrange for a substitute photographer of equal technical ability to fulfil this agreement. If the clients decline this appointment they may terminate the agreement and will receive a full refund of all monies paid.

Engagement Portrait

If circumstances allow, the photographer may offer a preliminary session with the clients. This will be an opportunity to meet and become comfortable with one another and to receive a complimentary portrait. Location, date and terms and conditions will be agreed.

Copyright and Usage

The copyright remains the property of the photographer. The photographer reserves the right to use the images for self-promotion and portfolio. The photographer will not use any image for other commercial purposes without specific written consent from the clients. The clients are not authorised to use the images for their own or anyone else’s commercial gain or promotion. The clients may make use of any digital images supplied by the photographer for email, web or personal printing. The clients may not sell reprints or digital images.

This agreement and any attached written agreements will not be amended except with written consent of all parties.
